

# CONSENT TO THE PROCESSING OF PERSONAL DATA OF USERS - INDIVIDUALS

**I, the User, by accessing the website [www.brics-pay.com](http://www.brics-pay.com) (hereinafter referred to as the Website), voluntarily, of my own free will, and in my own interests, and confirming my legal capacity in accordance with the provisions of Federal Law No. 152-FZ of July 27, 2006 "On Personal Data," sign this Consent and authorize (express my unconditional consent) (hereinafter referred to as the Consent) BRICS PAY JSC, Legal address: 109052, Moscow, internal territory of the Nizhegorodsky municipal district, Ryazansky prospect, building 3B, office 17/3, Taxpayer Identification Number (INN): 9721251889, to process my personal data under the following conditions:**

1. This consent is given for the processing of personal data, both without the use of automated tools and with their use (through mixed processing).
2. Consent is given for the processing of the following personal data:  
contact information, including email address, user data (location information; OS type and version; browser type and version; device type and screen resolution; the source from which the user accessed the website; where the app was downloaded; the website or ad from which the user downloaded the app; OS and browser language; the pages the user opens and the buttons the user clicks; IP address).
3. Personal data is not publicly available.
4. Purpose of personal data processing: processing incoming requests from individuals for the purpose of providing consulting and services; analyzing individual actions on the website and website operation; conducting advertising and newsletters;
5. The basis for processing personal data is: Article 24 of the Constitution of the Russian Federation; Article 6 of Federal Law No. 152-FZ "On Personal Data"; the Charter of BRICS Pay JSC; this consent to the processing of personal data.
6. To the extent necessary to achieve the purposes specified in paragraph 4, BRICS Pay JSC may process my personal data in the following ways: collection, recording (including recording on electronic media), systematization, accumulation, storage, compilation of lists, marking, clarification (updating, modification), retrieval, use, depersonalization,

blocking, deletion, destruction, processing of personal data using computer technology, obtaining images by scanning, photographing and video recording, as well as performing any other actions with personal data permitted by the legislation of the Russian Federation.

I consent to BRICS Pay JSC providing my personal data to third parties without notifying me or obtaining additional consent from me to the extent necessary to achieve the purposes specified in paragraph 4. At the same time, BRICS Pay JSC takes measures to protect personal data during its circulation in accordance with Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006.

8. This Consent to the Processing of Personal Data is valid indefinitely from the date it is provided. At least 30 (thirty) calendar days prior to the revocation of consent.

If the personal data subject or their representative revokes their consent to the processing of personal data, BRICS Pay JSC reserves the right to continue processing the personal data without the consent of the personal data subject. This is provided that the grounds specified in paragraphs 2–11 of Part 1 of Article 6, Part 2 of Article 10, and Part 2 of Article 11 of Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006 exist.
